Subject: - Inviting applications for fresh allotment / change of various categories of Police Pool Houses.

As per new Standing Order on House Allotment of Chandigarh Police, duly approved by W/IGP and issued vide No.59/UT(-5) dated 9.12.2013, applications were invited from the eligible employees for Fresh allotment as well as for the change of Police Pool House but sufficient response has not been received in this regard.

At present 122 Police Pool houses of different categories (Sector/Floor-wise detail is enclosed) are available for allotment to the eligible employees of Chandigarh Police department as per new Standing Order on House Allotment of Chandigarh Police, duly approved by W/IGP and issued vide No.59/UT(-5) dated 9.12.2013. The desirous applicants (Employees appointed in Chandigarh Police upto 2005 in case of **Fresh Allotment** and employees having Police Pool house and completed two years in the allotted house and also not availed any change the entitled category can apply for **Change of Police Pool House**) may submit their applications on the prescribed performa (Specimen enclosed) duly filled in by **7.2.2014**. The entitlement of each category has been shown in **Annexure-'A'** appended on the reverse of the **application Form**.

Those, who are already in occupation of Govt. accommodation of lower category then their entitlement as at **Annexure-A**, but want higher type as per entitlement should also submit their applications for fresh allotment.

An officer/official can apply for one category of house only to which he is entitled as per **Annexure-'A'**. Application Form submitted for allotment of house other than the entitled category would automatically stand rejected.
