Working Career:

Well educated, Shri Rajinder Singh Ghumman, IPS, after completing his Post Graduation (B.A., L.L.M) joined Police Force as Asst. Commissioner of Police (ACP) in 1983 in DANIPS Cadre on the basis of combined civil services exam (1981) conducted by Union Public Service Commission. He served on many important postings in Delhi Police started with District Mayabunder as DSP in year 1987-88. Thereafter, he perfectly served North & West District, Defence Colony, Vivek Vihar, Crime & Railways and Kalyan Puri as Assitant Commissioner of Police (ACP) from 1988 to 1996. During this long period, prevention and detection of crime was exemplary. During terrorism days, he volunteered to serve Punjab Police and hence joined as SP Security to Chief Minister Punjab from the year 1993 to 1994. As Addl. DCP, he served Central & South Distt. & Crime and Railways.
